Response request for official information relating to Let's Get Wellington Moving

I refer to your request for official information received 17 May 2019 relating to Let's Get Wellington Moving. We have processed your request under the Local Government Official Information and Meetings Act (LGOIMA) 1987.

- 1. A copy of any documents received from other Councils, NZTA, Ministers offices, government agencies (including the Ministry of Transport and Treasury) or the Let's Get Wellington Moving joint initiative, relating to the Let's Get Wellington Moving initiative, or similar.**

We have provided relevant information as Attachment 1.

We have transferred substantive aspects of your request to the other Councils who coordinate inter-Council forums where Let's Get Wellington Moving and related initiatives have been discussed, under section 12 of LGOIMA. This involves the following:

- Where Let's Get Wellington Moving has been discussed at meetings of the Wellington Regional Strategy Committee, Wellington Regional Transport Committee and any other related cross-Council meetings hosted by Greater Wellington Regional Council, this aspect has been transferred to Greater Wellington Regional Council as lead coordinator of these forums.
- Where Let's Get Wellington Moving has been discussed at meetings of the Regional CEOs Forum, this aspect has been transferred to Wellington City Council as lead coordinator of this forum.
- Where Let's Get Wellington Moving has been discussed at meetings of the Wellington Mayoral Forum, this aspect has been transferred to Upper Hutt City Council as lead coordinator of this forum.

You should be aware that a response from these agencies must be provided to you as soon as reasonably practicable, and no later than 20 working days after the day this transfer is received by their agency, unless an extension of time is required and notified to the requester.

- 2. Please include documents that relate to the initiative as a whole, or any of the potential projects included in the initiative (mass transit from wellington city to wellington southern suburbs, either bus, bus rapid transit, light rail or trackless trams; extra Mt Victoria Tunnel; Basin Reserve Improvement; extra terrace tunnel; Te Aro tunnel and park (relocate southbound traffic from Vivian St into a tunnel under Te Aro); Ruahine St / Wellington Road widening).**

Porirua City Council has not been involved in these discussions.

- 3. Please also include in this request documents that relate to funding proposals for such projects.**

4. **Please limit this request to documents (pdf, word, physical, etc) since September 1st 2018, and emails since March 1st 2019**
